The Canadian Armed Forces (CAF) wishes to advise you of the revised Occupational Therapy benefit codes in all provinces under Program of Choice (POC) 12 - Related Health Services, **effective April 1st, 2022.**

240110	Occupational Therapy In-Home Visit	Renamed	Prescribe: MD, PA, NP, PT, or OT. Pre-Authorization: YES Frequency: 10/CY		
240163	CFHS Requested Occupational Therapy Report	Renamed	Prescriber: MD, PA, NP, PT, or OT. Pre-Authorization: YES		
240150	Functional Capacity Evaluation (FCE)	Terminated	This type of assessment is done in-clinic setting.		
240153	Occupational Therapist—Home Modifications/Adaptation Assessment	Terminated	This type of assessment is already covered under OT In-Home Assessment code.		
240154	Occupational Therapist—Vehicle Modifications/Adaptation Assessment	Terminated	This type of assessment can be covered under OT In-Home or In-Clinic Assessment code.		





240156	Home Care—Needs Assessment by OT	Terminated	This assessment can be covered under OT In-Home Assessment code.
240171	Occupational Therapist Virtual (Care/Treatment) Follow-up	Unchanged	This code is used for tele- health follow-up.

Additional Information for Occupational Therapy Services

- Occupational Therapy In-Clinic Assessment benefit code 240270
 - o must be in-person;
 - o used for in-clinic/outpatient setting initial assessment;
 - o includes the written report, and
 - in-clinic assessment allows OT to assess members using different standardized assessments, splint fabrication or use of specialized equipment.
- Occupational Therapy In-Clinic Visit benefit code 240275
 - in-clinic follow-ups typically include use of therapeutic exercise and activity for return to duty, upper extremity strengthening, cognitive rehabilitation, etc., and
 - a progress report must be submitted halfway through the treatment plan or at any point in time when treatment goals are modified or when new information should be shared with the healthcare team.
- Occupational Therapy In-Home Assessment benefit code 240151
 - o must be in-person;
 - o used for in-home initial assessments, and
 - includes the written report and associated travel to and from the member's home. Distance must be calculated from the OT's office.
- Occupational Therapy In-Home Visit benefit code 240110
 - must be in-person;
 - follow-up visits typically include ADL/IADL retraining, equipment recommendations, home modification suggestions and caregiver education, and
 - a progress report must be submitted halfway through the treatment plan or at any point in time when treatment goals are modified or when new information should be shared with the healthcare team.
- CFHS Requested Occupational Therapy Report benefit code 240163
 - this code only applies when CFHS is requesting additional written information or amendment to a report.

- Virtual Care Follow-up/Treatment benefit code 240171
 - virtual care is considered communication with members via telephone or a secure virtual platform;
 - can be combined with in-person treatment sessions (up to a maximum of 4 virtual sessions per calendar year), and
 - providers must ensure there is a plan in place to manage adverse events and emergencies.
